OLD BUSINESS

NEW BUSINESS

Copy Machine- Jesse Perry Representative from Copy Pro- Motion made by Commissioner Porter and 2nd by Commissioner Haislip to lease the printer from Copy Pro for 5 years with the option to get a new machine every 3 to 4 years. Which includes 1,000 black/white prints per month and 250 color prints per month. toner, parts, labor, shipping, travel fees and the stand for the printer. In the amount of \$120.61 per month. Motion passed unanimously

Security System- Tabled to September meeting to get a bid from ADT. CPI gave a bid of \$59.99 per month.

Utility Bills-A motion was made by Commissioner J. Haislip and 2nd by Commissioner S. Harrell to change the utility bills from regular paper to cards just like the water bills the citizens get. Commissioner Harrell is to assist Town Clerk/Commissioner Porter in looking for some quality and reasonable prices for card stock to begin purchasing to print new utility bills. Motion passed unanimously

Oak City Stop and Go- The owner of the Stop and Go called and spoke with Mayor Stalls as well as the Town clerk about his balance for his utility bill. Ash who owns Oak City Stop and Go stated that his last utility bill was paid by his brother as well as an additional \$250.00 to take care of the new owner obtaining the property. Ash stated his brother Moe paid this to the former Town Clerk but there is no record of it being paid and it was not posted to the account. A decision was made that the owner Oak City Stop and Go will have to produce a receipt to show that the bill was paid before the Town Clerk can credit the account.
