Baker Gas out of Williamston offered the town \$1.79.9 a gallon with no deliver fees. Commissioner Turner made a motion for the town to accept and sign the contract with Baker Gas. Commissioner Easley 2nd the motion. **Motion was passed 4-0**

Trunk a Treat- Mayor Pro-tem/Commissioner Harrell asked the board to consider sponsoring a Trunk a Treat at the town commons on Friday, October 29, 2021 from 6:00 p.m.-8:00 p.m.

The town would purchase the trick or treat bags at a cost of \$50 that will be used that day.

The churches, Fire/Rescue department and business will be asked to set up a table/trunk of a car at this even. We will block off North East Street from the corner of Commerce Street and to West Pine Street
